Section 1. Researcher

The award of a grant does not constitute an opinion of *the Society* on the planned research, nor does it indicate approval by *the Society* of the results of the research. *The Society* shall not be responsible for any loss, injury, or damage arising out of the research or actions of the researcher.

Should his/her project be funded, the researcher authorizes *the Society* to transmit the summary of the aforementioned research project as well as his/her name, profile, and photograph. This information could be used in *the Society's* annual report, on its website, and in documents of information published from time to time by *the Society*, as well as with donors, partners, and mass media. *The Society* undertakes, to the best of its abilities, to inform the researcher of the use of such information. The researcher agrees to participate, from time to time, in interviews aiming at promoting *the Society* and its work. The researcher further agrees to acknowledge *the Society* in all their publications, presentations, etc. relative to the support received from *the Society* through the award of its grant.

The researcher agrees to comply at all times with the general principles of honesty and scientific ethics, especially in relation to the use for the intended purpose of the research funds received from *the Society*.

Section 2. Institution of Researcher

The researcher's institution hereby agrees to indemnify and hold harmless the Cancer Research Society (*the Society*), its officers, directors, representatives, and employees from any claims, demands, judgments, or orders made against *the Society* and/or the aforementioned persons, arising out of the work carried on by virtue of a grant from *the Society* or the actions of the researcher while carrying out such work. Without limiting the generality of the foregoing, this indemnity shall include legal fees and expenses should *the Society* or its officers, directors, representatives, or employees be called upon to defend a claim or action relating to the work or actions of the researcher pursuant to the receipt of a grant from *the Society*.

Ensuring the proper use of *the Society's* funds is incumbent upon the recipient's university or research centre. Any misuse, fraud or misappropriation of *the Society's* funds perpetrated by the researcher shall trigger immediate reimbursement of the misused funds to *the Society* by the recipient's institution. The university or research centre shall advise *the Society* promptly in writing upon the discovery or occurrence of such misappropriation of funds and proceed accordingly.

The recipient's university or research centre must notify *the Society* without any delay should a researcher 1) announce his/her intention of leaving the institution, or 2) cannot pursue his/her research at the institution for reasons such as departure, long-term sick leave, etc. In these situations, the Institution is fully responsible for any funds disbursed ahead of the scheduled grant installments and such funds will not be refunded by *the Society*.
